2. COMPOSITION/INFORMATION ABOUT THE INGREDIENTS

Chemical identification: Cosmetic mixture composed primarily of sugar, vegetable oils and botanical ingredients.

INCI formula: Sucrose (Sugar), Vitis Vinifera (Grape) Seed Oil, Simmondsia Chinensis (Jojoba) Seed Oil, Caprylic/Capric Triglyceride, Copaifera Reticulata Resin Oil, Fragrance, Melaleuca Alternifolia (Tea Tree) Leaf Oil.

3. HAZARDS IDENTIFICATION (DANGER ADVICE)

Classification of the substance or mixture:

Following regulation 1272/2008/CE (GHS/CLP): No specific hazards are encountered under normal product use.

According to Regulation (EC) No. 1272/2008 (CLP), this cosmetic product is not classified as hazardous under normal conditions of use.

The product is intended for external cosmetic use only. Avoid contact with eyes.

Do not apply on broken, severely irritated or infected skin.

Individuals with known sensitivity to essential oils or fragrance components should discontinue use if irritation develops.

4. FIRST-AID MEASURES

Contact with skin: Product is designed for topical skin application; if irritation occurs, discontinue use and rinse with water.

Contact with eyes: Wash abundantly with water for at least 10–15 minutes. If inflammation or traces of lesions persist, seek medical attention.

Swallowing: Rinse mouth with water. Do not induce vomiting. Seek medical advice if discomfort persists.

Inhalation: Not expected under normal use. If irritation occurs after accidental inhalation of vapors or aerosolized particles during bulk handling, move person to fresh air and seek medical advice if symptoms persist.

Most important symptoms and effects: Possible mild eye irritation on direct contact. Prolonged or excessive skin exfoliation may cause redness or mild irritation in sensitive individuals.

5. FIRE-FIGHTING MEASURES

Recommended extinguishers: Water spray, alcohol-resistant foam, dry chemical powder or carbon dioxide (CO₂).

Forbidden extinguishers: Do not use a direct water jet on large fires involving oil-containing materials, as it may spread the burning material.

Risks from combustion: The product is not considered highly flammable under normal storage conditions. In case of fire, thermal decomposition may produce carbon monoxide (CO), carbon dioxide (CO₂), smoke and irritating fumes.

Protection means: Firefighters should wear appropriate protective clothing and self-contained breathing apparatus (SCBA) when fighting large fires.

6. MEASURE IN CASE OF ACCIDENTAL RELEASE

Individual precautions: Avoid contact with eyes; use normal hygiene precautions when cleaning large spills.

Environmental-precautions: Keep significant quantities away from surface/ground water, drains and soil because the oily scrub may make surfaces slippery and should not be discharged in large amounts into the environment.

Cleansing Method: Scoop or absorb product with inert material such as paper, cloth, sand, or earth and place into suitable containers for disposal. Wash the spill area with large amounts of water after bulk material is removed.

7. HANDLING AND STORAGE

Handling:

- Handle in accordance with good cosmetic and hygiene practices.
- For external use only.
- Avoid contact with eyes and mucous membranes.
- Do not use on broken, irritated, or freshly traumatized skin.
- No special handling precautions are required under normal use.

Storage:

- Store in a cool, dry place, away from direct sunlight and heat sources.
- Keep container tightly closed when not in use.
- Store at temperatures below 25°C (77°F) for optimal stability.
- Keep out of reach of children.

Exposure check: No special exposure controls are required for normal consumer use. Avoid eye contact.
